ISSUE PRICE OF NEW UNITS PURSUANT TO THE DISTRIBUTION REINVESTMENT PLAN

Cambridge Industrial Trust Management Limited, as manager of Cambridge Industrial Trust ("CIT" and the manager, the "Manager") wishes to announce that the issue price of the new units in CIT pursuant to the application of the Distribution Reinvestment Plan to CIT's distribution for the quarter ended 30 June 2012 ("DRP Units") is S\$0.5776 per DRP Unit.

The issue price represents a discount of 2% to the volume-weighted average traded price per unit in CIT ("Unit") on the Singapore Exchange Securities Trading Limited (the "SGX-ST") from 1 August 2012 to 3 August 2012 (both dates inclusive).
