**ISSUE AND LISTING OF NEW UNITS  
UNDER THE DISTRIBUTION REINVESTMENT PLAN**

Cambridge Industrial Trust Management Limited, as manager of Cambridge Industrial Trust ("CIT" and the manager, the "Manager") wishes to announce that the Manager has today issued 7,327,516 new units in CIT at an issue price of S\$0.6980 per unit pursuant to CIT's Distribution Reinvestment Plan ("New Units") in respect of the distribution of 1.251 cents per unit for the period from 1 April 2014 to 30 June 2014 (the "2Q2014 Distribution").

The New Units will commence trading on the Main Board of Singapore Exchange Securities Trading Limited (the "SGX-ST") at 9.00am on 10 September 2014.

The New Units will rank pari passu in all respects with the existing units in CIT ("Units").

Following the issue of the New Units, the number of issued Units will increase from 1,255,547,939 to 1,262,875,455.

Eligible unitholders of CIT ("Unitholders") who did not elect to participate in the Distribution Reinvestment Plan and overseas Unitholders who did not provide registered addresses in Singapore to CDP will receive all of their entitlements to the 2Q2014 Distribution in cash on 10 September 2014.

Cambridge Industrial Trust (“CIT”), publicly listed on the Singapore Exchange Securities Trading Limited since 25 July 2006, is Singapore’s first independent industrial real estate investment trust (“REIT”).

CIT invests in quality income-producing industrial properties and has a diversified portfolio of 48 properties located across Singapore, with a total gross floor area of approximately 8.1 million sq ft and a property value of S\$1.3 billion as at 30 June 2014. They range from logistics, warehousing, light industrial properties, general industrial to car showroom and workshop properties, which are located close to major transportation hubs and key industrial zones island-wide.

The Manager’s objective is to provide Unitholders with a stable and secure income stream through the successful implementation of the following strategies:

- Acquisition of value-enhancing properties;
- Pro-active asset management;
- Divestment of non-core properties; and
- Prudent capital and risk management.

Cambridge Industrial Trust Management Limited, the Manager of CIT, is indirectly owned by three strategic sponsors, namely, National Australia Bank Group (“NAB”) (56%), Oxley Group (24%) and Mitsui & Co., Ltd (“Mitsui”) (20%):

Mitsui also developed the Japan Logistics Fund Inc., a publicly listed REIT in Japan dedicated to investing in distribution facilities.
