Wealthy Fountain Holdings Inc holds 190,924,226 ESR-REIT units and Skyline Horizon Consortium Ltd holds 13,172,094 ESR-REIT units. Both entities are wholly owned by Shanghai Summit Pte Ltd ("SSPL"). ESR-FM holds 30,605,531 ESR-REIT units and is 25% owned by SSPL.

Leading Wealth Global Inc holds 670,209,878 ESR-REIT units and is a wholly-owned subsidiary of Longemont Real Estate Pte Ltd, which is in turn a wholly-owned subsidiary of Shanghai Summit (Group) Co., Ltd.

Both SSPL and Shanghai Summit (Group) Co., Ltd are wholly owned by Tong Jinqian. Therefore, Tong Jinqian is deemed to be interested in the 904,911,729 ESR-REIT units held by the above-mentioned entities.
