**ISSUE OF NEW UNITS PURSUANT TO THE  
ESR-REIT DISTRIBUTION REINVESTMENT PLAN**

ESR Funds Management (S) Limited, as manager of ESR-REIT (the “**Manager**”), wishes to announce that 12,677,397 new units in ESR-REIT (“**Units**”) will be issued today at an issue price of S\$0.4017 per Unit pursuant to the ESR-REIT Distribution Reinvestment Plan in respect of the distribution of 0.800 cents per Unit for the period from 1 January 2021 to 31 March 2021 (the “**1Q2021 Distribution**”).

The aforementioned new Units will commence trading on the Main Board of Singapore Exchange Securities Trading Limited at 9.00 a.m. today. The new Units will, upon issue and listing, rank *pari passu* in all respects with the existing Units in issue. Following the issue of the new Units, the total number of Units in issue is 3,877,236,558.

Eligible unitholders of ESR-REIT (“**Unitholders**”) who did not elect to participate in the ESR-REIT Distribution Reinvestment Plan and Unitholders with registered addresses outside Singapore who did not provide an address in Singapore to The Central Depository (Pte) Limited will receive all of their entitlements to the 1Q2021 Distribution in cash today.
