RESULTS OF THE PREFERENTIAL OFFERING

*Capitalised terms used herein, but not otherwise defined, shall have the meanings ascribed to them in the announcement of ESR-REIT dated 27 July 2021 titled “Launch of Preferential Offering on the Basis of 32 Preferential Offering New Units for Every 1,000 Existing Units to Raise Gross Proceeds of Up To Approximately S\$50.0 Million” (the “**Launch Announcement**”) and/or the instruction booklet of ESR-REIT in respect of the Preferential Offering dated 10 August 2021.*

1. RESULTS OF THE PREFERENTIAL OFFERING

Further to the Launch Announcement and the announcements dated 27 July 2021 and 10 August 2021 in relation to the *pro rata* and non-renounceable preferential offering of approximately 124.1 million Preferential Offering New Units (the “**Preferential Offering**”), ESR Funds Management (S) Limited, as manager of ESR-REIT (the “**Manager**”), wishes to announce that as at the close of the Preferential Offering on 18 August 2021, valid acceptances and excess applications¹ were received for a total of 452,156,111 Preferential Offering New Units, representing approximately 364.4% of the total number of Preferential Offering New Units. Details of the valid acceptances and excess applications received are as follows:

The balance of 47,277,498 Preferential Offering New Units which were not validly accepted will be allotted to satisfy applications for Excess New Units. In the allotment of Excess New Units, preference will be given to the rounding of odd lots. Directors of the Manager and Substantial Unitholders who have control or influence over ESR-REIT or the Manager in connection with the day-to-day affairs of ESR-REIT or the Manager or the terms of the Preferential Offering, or have representation (direct or through a nominee) on the board of directors of the Manager, will rank last in priority for the rounding of odd lots and allotment of Excess New Units.

Pursuant to the Preferential Offering, a total of 124,071,569 Preferential Offering New Units at the issue price of S\$0.400 per Preferential Offering New Unit will be issued to raise gross proceeds of approximately S\$49.6 million. Together with the gross proceeds of approximately S\$100.0 million raised from the private placement of 268,818,000 Units to institutional and other investors, total gross proceeds of approximately S\$149.6 million have been raised from the Equity Fund Raising.

2. UNDERTAKING BY THE SPONSOR

Pursuant to the Sponsor Irrevocable Undertaking, ESR Cayman Limited (the “**Sponsor**”), which owns 361,689,293 Units representing approximately 9.3% of the total number of Units in issue as at the Preferential Offering Record Date through its subsidiaries, has procured the Sponsor Relevant Entities, which own 320,954,107 Units representing approximately 8.3% of the total number of Units in issue as at the Preferential Offering Record Date, to subscribe and pay in full for their provisional allotment of 10,270,531 Preferential Offering New Units. As the Preferential Offering was oversubscribed, the Sponsor Relevant Entities did not make excess applications for any Excess Preferential Offering Units.

The total subscription of the Sponsor Relevant Entities amounted to approximately S\$4.1 million. Immediately post-completion of the Preferential Offering, the Sponsor Relevant Entities will have an aggregate interest in 331,224,638 Units, representing approximately 8.3% of the total number of 4,001,308,127 Units in issue after the listing and quotation of 124,071,569 Preferential Offering New Units, and the Sponsor will have an aggregate interest in 371,959,824 Units, representing approximately 9.3% of the total number of 4,001,308,127 Units in issue after the listing and quotation of 124,071,569 Preferential Offering New Units.

3. REFUNDS

In relation to any void or invalid acceptances of Preferential Offering New Units or any unsuccessful applications for Excess New Units under the Preferential Offering, all monies received in connection therewith will be returned by The Central Depository (Pte) Limited (“**CDP**”) on behalf of ESR-REIT to the Entitled Unitholders, without interest or any share of revenue or other benefit arising therefrom, within three (3) business days after the commencement of trading of the Preferential Offering New Units on 26 August 2021, by crediting their accounts with the relevant Participating Banks² (where acceptance and/or application is made through an ATM of a Participating Bank) or by crediting their designated bank accounts via CDP’s Direct Crediting Service (where acceptance and/or application is made through CDP (including through the submission of the ARE or application through an

Accepted Electronic Service including PayNow)) and, in each case, at the Entitled Unitholders' own risk. In the event that such Entitled Unitholders are not subscribed to CDP's Direct Crediting Service, any monies to be refunded will be retained by CDP and reflected under the Cash Transaction section of their CDP monthly account statement.

4. STATUS OF THE PREFERENTIAL OFFERING NEW UNITS

The Manager expects the Preferential Offering New Units to be listed and quoted on the Main Board of Singapore Exchange Securities Trading Limited (the "SGX-ST") with effect from 9.00 a.m. on 26 August 2021.

The Preferential Offering New Units to be issued will, upon issue and listing, rank *pari passu* in all respects with the Units in issue on the day immediately prior to the date on which the Preferential Offering New Units are issued, including the right to distributions out of ESR-REIT's distributable income from the date of issuance of the Preferential Offering New Units, as well as all distributions thereafter.

The Manager wishes to take this opportunity to thank Unitholders for their support in the successful completion of the Preferential Offering.

ESR-REIT invests in quality income-producing industrial properties and as at 30 June 2021 holds interest in a diversified portfolio of 58 properties located across Singapore, with a total gross floor area of approximately 15.6 million square feet and an aggregate property value of S\$3.2 billion³. The properties are in the following business sectors: Business Park, High-Specs Industrial, Logistics/Warehouse and General Industrial, and are located close to major transportation hubs and key industrial zones island-wide. ESR-REIT also holds a 10.0% interest in ESR Australia Logistics Partnership, a private fund comprising 37 predominantly freehold logistics properties all located in Australia.
