**ISSUE OF NEW UNITS PURSUANT TO THE
ESR-REIT DISTRIBUTION REINVESTMENT PLAN**

ESR Funds Management (S) Limited, as manager of ESR-REIT (the “**Manager**”), wishes to announce that 17,959,796 new units in ESR-REIT (“**Units**”) will be issued today at an issue price of S\$0.4695 per Unit pursuant to the ESR-REIT Distribution Reinvestment Plan in respect of the distribution of 0.712 cents per Unit for the period from 1 July 2021 to 30 September 2021 (the “**3Q2021 Distribution**”).

The aforementioned new Units will commence trading on the Main Board of Singapore Exchange Securities Trading Limited at 9.00 a.m. today. The new Units will, upon issue and listing, rank *pari passu* in all respects with the existing Units in issue. Following the issue of the new Units, the total number of Units in issue is 4,030,257,149.

Eligible unitholders of ESR-REIT (“**Unitholders**”) who did not elect to participate in the ESR-REIT Distribution Reinvestment Plan and Unitholders with registered addresses outside Singapore who did not provide an address in Singapore to The Central Depository (Pte) Limited will receive all of their entitlements to the 3Q2021 Distribution in cash today.

ESR-REIT has been listed on the Singapore Exchange Securities Trading Limited since 25 July 2006.

ESR-REIT invests in quality income-producing industrial properties and as at 30 June 2021 holds interest in a diversified portfolio of 58 properties located across Singapore, with a total gross floor area of approximately 15.6 million square feet and an aggregate property value of S\$3.2 billion¹. The properties are in the following business sectors: Business Park, High-Specs Industrial, Logistics/Warehouse and General Industrial, and are located close to major transportation hubs and key industrial zones island-wide. ESR-REIT also holds a 10.0% interest in ESR Australia Logistics Partnership, a private fund comprising 36 predominantly freehold logistics properties all located in Australia.

The Manager's objective is to provide Unitholders with a stable income stream through the successful implementation of the following strategies:

- Acquisition of value-enhancing properties;
- Proactive asset management;
- Divestment of non-core properties; and
- Prudent capital and risk management.
