**PAYMENT OF MANAGEMENT FEES
BY WAY OF ISSUE OF NEW UNITS IN ESR-LOGOS REIT**

ESR-LOGOS Funds Management (S) Limited, the manager of ESR-LOGOS REIT (the “**Manager**”), is pleased to announce that 10,916,092 new units in ESR-LOGOS REIT (“**Units**”) have been issued to the Manager (8,663,927 new Units) and ESR-LOGOS Property Management (S) Pte Ltd, the property manager of ESR-LOGOS REIT (the “**Property Manager**”) (2,252,165 new Units) today.

The new Units were allotted at an issue price of S\$0.3792 per Unit as partial payment for the Manager’s base fees and the Property Manager’s property management fees for the period from 1 October 2022 to 31 December 2022 (“**4Q2022**”).

The issue price was determined based on the volume weighted average price per Unit for all trades on Singapore Exchange Securities Trading Limited in the ordinary course of trading for the last ten (10) business days of 4Q2022.

Following the above issuance of new Units, the total number of Units in issue is 6,730,104,079 of which the Manager’s holding is 110,740,318 Units and the Property Manager’s holding is 25,135,550 Units, representing 1.65% and 0.37% of the total number of Units in issue, respectively.
