When Mr Loi was going through the internal compulsory induction training for new directors held by the ESR-LOGOS REIT Manager on 26 June 2023, he was made aware that he will also be deemed to have an interest in any units held by his spouse. Mr Loi then immediately filed his notification to disclose his deemed interest in the 138,320 units held by his wife, and replaced his earlier notification. The direct and deemed interest held by Mr Loi in units in ESR-LOGOS REIT (and as reflected in this replacement form) have not changed since Mr Loi's first appointment as a director of ESR-LOGOS Funds Management (S) Limited on 15 May 2023.
