**PAYMENT OF MANAGEMENT FEES  
BY WAY OF ISSUE OF NEW UNITS IN ESR-LOGOS REIT**

ESR-LOGOS Funds Management (S) Limited, the manager of ESR-LOGOS REIT (the “**Manager**”), is pleased to announce that 12,524,721 new units in ESR-LOGOS REIT (“**Units**”) have been issued to the Manager (9,900,123 new Units) and ESR-LOGOS Property Management (S) Pte Ltd, the property manager of ESR-LOGOS REIT (the “**Property Manager**”) (2,624,598 new Units) today.

The new Units were allotted at an issue price of S\$0.3280 per Unit as partial payment for the Manager’s base fees and the Property Manager’s property management fees for the period from 1 April 2023 to 30 June 2023 (“**2Q2023**”).

The issue price was determined based on the volume weighted average price per Unit for all trades on Singapore Exchange Securities Trading Limited in the ordinary course of trading for the last ten (10) business days of 2Q2023.

Following the above issuance of new Units, the total number of Units in issue is 7,685,359,262 of which the Manager’s holding is 130,686,924 Units and the Property Manager’s holding is 30,304,817 Units, representing 1.70% and 0.39% of the total number of Units in issue, respectively.
