ESR-LOGOS REIT COMPLETES DIVESTMENT OF 3 PIONEER SECTOR 3, 21 CHANGI NORTH WAY AND 30 TOH GUAN ROAD IN SINGAPORE

Capitalised terms used herein, but not otherwise defined, shall have the meanings ascribed to them in the announcement of ESR-LOGOS REIT dated 23 June 2023 titled “PROPOSED DIVESTMENT OF A PORTFOLIO OF 5 ASSETS WITH AN AGGREGATE SALE CONSIDERATION OF S\$313.5 MILLION” (the “Divestment Announcement”).

On 23 June 2023, ESR-LOGOS Funds Management (S) Limited, as manager of ESR-LOGOS REIT (the “**Manager**”), announced the proposed divestment of 5 non-core assets, namely 3 Pioneer Sector 3, 4 & 6 Clementi Loop, 6 Chin Bee Avenue, 21 Changi North Way and 30 Toh Guan Road for a total sale consideration of S\$313.5 million (excluding divestment costs and applicable goods and services tax, if any).

Further to the Divestment Announcement, the Manager is pleased to announce that:

- (i) Perpetual (Asia) Limited (in its capacity as trustee of E-LOG) (the “**E-LOG Trustee**”) has today completed the divestment of 3 Pioneer Sector 3 for a sale consideration of S\$95.0 million;
- (ii) HSBC Institutional Trust Services (Singapore) Limited (in its capacity as trustee of ALOG Trust) has today completed the divestment of 21 Changi North Way for a sale consideration of S\$30.1 million; and
- (iii) E-LOG Trustee has today completed the divestment of 30 Toh Guan Road for a sale consideration of S\$57.8 million.

The completion of the divestment of the remaining assets is currently underway, and the Manager will make the relevant announcement(s) upon completion of these divestments.

Following the completion of the above three divestments, ESR-LOGOS REIT’s diversified portfolio consists of 77 properties (excluding 48 Pandan Road held through a joint venture) located across Singapore, Japan and Australia, as well as investments in three property funds in Australia.
