ESR-LOGOS REIT COMPLETES DIVESTMENTS OF 70 SELETAR AEROSPACE VIEW AND 2 TUAS SOUTH AVENUE 2 IN SINGAPORE

Capitalised terms used herein, but not otherwise defined, shall have the meanings ascribed to them in the announcements of ESR-LOGOS REIT dated 19 December 2022 titled "ESR-LOGOS REIT DIVESTS 70 SELETAR AEROSPACE VIEW AT 4.8% PREMIUM TO VALUATION" and dated 2 October 2023 titled "ESR-LOGOS REIT DIVESTS 2 TUAS SOUTH AVENUE 2 AT 35.2% PREMIUM TO VALUATION" (the "Divestment Announcements").

Further to the Divestment Announcements, ESR-LOGOS Funds Management (S) Limited, as manager of ESR-LOGOS REIT, is pleased to announce that Perpetual (Asia) Limited, in its capacity as trustee of ESR-LOGOS REIT, has completed the divestments of 70 Seletar Aerospace View for a sale consideration of approximately S\$7.1 million (representing a 4.8% premium to valuation¹) and 2 Tuas South Avenue 2 for a sale consideration of S\$53.0 million (representing a 35.2% premium to valuation²).

Following the completion of the divestments, ESR-LOGOS REIT's diversified portfolio consists of 72 properties (excluding 48 Pandan Road held through a joint venture) located across Singapore, Japan and Australia, as well as investments in three property funds in Australia.
